Prior to joining the Foodbank, I worked on ensuring equitable access to food on the *Missouri S&T* college campus in Rolla, MO. Additionally, I worked as a lobbyist for higher education students interests in the Missouri State Legislature on behalf of the *Associated Students of the University of Missouri*. In my time at the Capitol during the 2023 Regular Session, I got two

bills passed expanding access to medical practitioners and counselors for MO residents and helped implement a new position on all UM campuses to connect students with public and community resources for basic needs insecurity.

I look forward to working across the St. Louis Area Foodbank's network to implement the grassroots advocacy program in our neighbor's communities. Through outreach, education, and action we hope to strengthen our neighbors and partners understanding of SLAFB's mission and inspire them to empower our communities, feed each other and transform systems to better serve and advocate for the Greater St. Louis area.



# LEGISLATIVE PRIORITIES

For the calendar year 2024, St. Louis Area Foodbank has identified the following priorities at the Federal and State levels. St. Louis Area Foodbank will:

- Advocate for strong budget policies at the Federal and State levels that support social services, the non-profit sector, and programs that are vital to supporting and empowering our community. These include but are not limited to: SNAP, TANF, TEFAP, CSFP, and other programs that assist our neighbors in reaching their full potential.
- Advocate for administrative, distribution, and eligibility policies which preserve and strengthen programs that support and empower our community.
- Advocate for administrative and budgetary policies that break down barriers to access and create a more equitable system for our community.

## Farm Bill Advocacy Continues: Additional Resources Available

The continuing resolution signed into law in November that extended current government funding into early 2024 also extended the 2018 Farm Bill through Sept. 30, 2024, providing additional time for Congress to negotiate a new farm bill. Lawmakers have already stated their intention to move swiftly in early 2024 to consider farm bill legislation, so we must persist in calling on Congress to pass a farm bill that strengthens federal nutrition programs.
