CONTINUING RESOLUTION TO FUND GOVERMENT



In September, Congress passed—and the president signed —a bipartisan continuing resolution extending current government funding through Friday, Dec. 20 for all departments and agencies, including the USDA and our priority programs. This allows all federal nutrition programs to continue without disruption during this time. The continuing resolution includes flexible funding to ensure caseload management for the Commodity Supplemental Food Program (CSFP) and Women, Infants and Children (WIC). It also extends protections against EBT card fraud, known as SNAP skimming.

Members of Congress are now heading home for several weeks. When they return to Washington, D.C., after the November election, the network will vigorously advocate for our fiscal year 2025 appropriations priorities. If Congress fails to pass the necessary spending bills to fund the government by Dec. 20—or an additional continuing resolution—then the government will shut down on Saturday, Dec. 21.

Voting is one of the most fundamental rights and responsibilities in a democratic society. It serves as a powerful tool for citizens to voice their opinions and influence the direction of their communities and country. 🕎 SNAP NEWS

The USDA adjusts SNAP maximum allotments, deductions, and income eligibility standards at the beginning of each federal fiscal year. The fiscal year began on Oct. 1st. The changes are based on changes in the cost of living. Cost of living is the amount of money needed to support a basic standard of living.

The Thrifty Food Plan (TFP) calculates the cost of a market basket for a family of four. TFP is an estimate by the U.S. Department of Agriculture of how much it costs to provide nutritious, low-cost meals for a household. Maximum allotments are calculated from this cost every June.
